

Narrative

Initial:

On August 19, 2011 at approximately 0132 hours I, Off. Strong (while working for the BRPD Club Violence Task Force), responded to a 911 Call at 633 E. Boyd Dr. (Shady's Bar). This investigation is pending.

Investigation:

Headquarters advises that they received a 911 call from an unknown caller advising of a fight in progress at the above mentioned location. Upon arrival to the scene I didn't observe anyone fighting. I did observe a large crowd standing outside of the bar. I spoke to several people who advised that an unknown W/M was physically assaulted by a large crowd of people (approximately 10 to 15 people). I searched the immediate area and couldn't find a victim nor anyone involved in the actual altercation. While investigating, I was made aware that it was possible that LSU football players may have been involved in the altercation. I was told by a witness (who didn't want to be identified) that the people involved in the altercation may have gone to Reggie's Bar (1176 Bob Petit). The witness advises that the crowd that attacked the W/M left in a Silver vehicle (LA Lic# [REDACTED]). I was advised that the W/M (who was assaulted) left the scene in a black Chevrolet Silverado pickup truck ([REDACTED]). Being that I couldn't locate anyone involved in the altercation, I went to Reggie's to see if I could find any of the vehicles of the involved parties. Upon arrival on Bob Petit, officers searched the Tigerland area and were unable to locate any of the suspect vehicles. After searching, I made my way back to Shady's Bar to see if any complainants showed up (at approximately 0240 hours). Upon my arrival at the bar, I came in contact with Andrew Lowery. Lowery advises that he was assaulted by the large crowd of people.

Lowery advises that while standing outside in the parking lot of the bar, he observed several suspects that he believed were LSU football players (approximately 10-15 people) pull an unknown W/M out of a black Chevrolet Silverado pickup truck. He advises that the crowd began to severely beat the unknown W/M. Lowery advises that he intervened and managed to pull the unknown W/M away from the crowd. Lowery advises that he managed to get the unknown W/M back into his pickup truck. Lowery states that the unknown W/M was able to leave the parking lot. Lowery advises that the suspects then began to physically assault him. Lowery states that he was punched and kicked several times by the crowd. I observed that Lowery's face was swollen and had several bruises. Lowery also had blood on his shirt. Lowery advises that after beating him, the suspects got into a silver vehicle and left the scene. Lowery states that he believes that Jordan Jefferson and Josh Johns, both LSU football players, were two of the individuals who attacked him. Lowery declined medical attention and advised that he would be okay.

After speaking with Lowery, I was contacted by [REDACTED] [REDACTED] advises that she observed the entire altercation. [REDACTED] states that the entire altercation began because the unknown W/M's pickup truck was blocked in by a another vehicle. The unknown W/M yelled at the them to move the vehicle. [REDACTED] states that the crowd suddenly pulled the unknown W/M out of his pickup. [REDACTED] advises that after Lowery managed to rescue the W/M, he was attacked by the suspects. [REDACTED] advises that there were approximately ten suspects who attacked the unknown W/M. [REDACTED] advises that prior to the unknown W/M leaving, he threatened the crowd that he had a gun in his pickup truck. [REDACTED] states that she never observed the W/M with a gun. She advises that approximately five more suspects

joined in on the attack on Lowery. [REDACTED] advises that she believes that all were LSU football players because some she recognized as being on the team. The others were wearing official LSU Football shirts. [REDACTED] advises that she knows for certain that she observed Jordan Jefferson kicked Lowery in the face. [REDACTED] also advises that she observed Josh Johns as being one of the people who attacked Lowery. Lowery advises that she doesn't know the names of the other players but states that she could identify them through pictures if needed.

After speaking with both, Lowery was given his file number and instructed to contact me if he has any additional information.

At approximately 0445 hours I was notified by Ofc. B. Ogden that three individuals were at Earl K. Long hospital. Ogden advised me that the three individuals state that they were attacked by an unknown number of black males. All three individuals were unable to give any further descriptions of their attackers. Ofc. Ogden advises that these were the individuals that left the scene in the black Chevrolet Silverado. After receiving that information I contacted Lowery (via telephone) to see if he could verify that they were involved in the altercation. Lowery advises that he couldn't verify the others. While on the phone, Lowery informed me that he was at Our Lady of the Lake Hospital. Lowery states that after notifying his father of the altercation, he was forced (by his father) to go the hospital to get checked for injuries.

Conclusion:

At approximately 0610 hours I contacted Long who advises that Lowery was at home sleeping from the hospital. Long advises that Lowery didn't obtain any serious injuries. Lt. Newman was made aware of the altercations at Shady's (in which Night Captain Brown was inturn notified).

Nothing further, this case is open pending further investigation.
